Perceived corruption levels drop in key public institutions, but popular trust yet to follow suit

Popular perceptions of corruption in Tanzania's public institutions have declined significantly, including for four agencies that are key to the fight against corruption: the Tanzania Revenue Authority (TRA), the Prevention and Combating Corruption Bureau (PCCB), the judiciary, and the police.

According to Afrobarometer's latest survey, perceptions of corruption in these four agencies have declined by double-digit percentage points in the period 2014-2017.

But public trust in these institutions has not (yet) shown comparable improvements.

These data are being released as the government of the United Republic of Tanzania continues to wage war against economic sabotage, including record revenue collections by the TRA and the PCCB's recovery of 78.2bn/- over the past two financial years of public funds which may have been embezzled. Key findings

- Perceptions of corruption in four key public institution thought to be among the most corrupt have declined significantly since 2014. About one in three Tanzanians (36%) think that "most" or "all" of the police are corrupt, down from 50% in 2014. One in five citizens (20%) say the same about judges and magistrates, 14% about TRA officials, 12% about PCCB officials (see Figure 1 below).
- The TRA enjoyed the largest decline in perceived corruption, a 23-percentage-point drop in the proportion of citizens who view "all" or "most" TRA officials as corrupt. Double-digit decreases were also recorded for the PCCB (18), judges and magistrates (14), and the police (14) (Table 1).
- But the decline in perceived corruption in public institutions has not produced a corresponding increase in popular trust (Table 2).

Afrobarometer


Afrobarometer is a pan-African, non-partisan research network that conducts public attitude surveys on democracy, governance, economic conditions, and related issues in Africa. Six rounds of surveys were conducted in up to 37 African countries between 1999 and 2016, and Round 7 surveys (2016/2017) are currently underway. Afrobarometer conducts face-to-face interviews in the language of the respondent's choice with nationally representative samples.

The Afrobarometer team in Tanzania, led by REPOA, interviewed 2,400 adult Tanzanians in April-June 2017. A sample of this size yields country-level results with a margin of error of +/-2%

at a 95% confidence level. Previous surveys have been conducted in Tanzania in 2014, 2012, 2008, 2005, 2003, and 2001.
