Background

The Afrobarometer (AB) is a comparative series of public opinion surveys on democracy, governance, economics, social development and civil society in Africa. It produces scientifically reliable public opinion data, builds research capacity among African institutions, and broadly disseminates practical results. Between 1999 and 2010, the Afrobarometer Network conducted four rounds of surveys in 20 African countries, which together laid a strong foundation for understanding trends in public opinion and for incorporating popular preferences into policy processes. Afrobarometer Rounds 5 and 6 (AB Round 5/6) will cover a period of almost 5 years, from April 2011 to December 2015, in up to 35 African Countries. This report covers Year 2 (2012) activities, which is the second year of Round 5.

R5 Objectives

The overall objectives of Afrobarometer Round 5 (R5) are:

- To expand the survey database in Africa by undertaking a fifth round of Afrobarometer surveys, and expanding the Network coverage by including up to 15 additional African countries.
- To enhance the visibility of the Afrobarometer among African Policy Actors through professionalization of the Afrobarometer's Communications Program, prioritizing the timeliness, accessibility and continuity in the release of results, and building ongoing engagement with stakeholders;
- To continue building Institutional Capacity for survey research and scientific analysis in Africa.
- To continue strengthening and indigenizing Network Management.

The program for AB Rounds 5 and 6 is being funded by a consortium of donors. Current Core Donors include the Swedish International Development Cooperation Agency (SIDA), the Mo Ibrahim Foundation (MIF), the United States Agency for International Development (USAID), and the Department For International Development, UK (DFID). The World Bank and the International Centre for Tax and Development at the Institute of Development Studies (IDS-ICTD), University of Sussex are also providing supplemental support.

AB R5 and R6 funds from SIDA, MIF, DFID, the World Bank and IDS-ICTD are contributed into the Afrobarometer Basket Fund, administered by the Ghana Center for Democratic Development (CDD-Ghana) via subcontracts to Afrobarometer Core Partners (CPs). In R5, the Core Partners have been expanded to include: the Institute for Democracy in South Africa (Idasa), the Institute for Empirical Research in Political Economy (IREEP) in Benin, the Institute for Development Studies (IDS) at the University of Nairobi in Kenya, and the Ghana Center for Democratic Development (CDD-Ghana). The Core Partners, in turn, will extend contracts to National Partners (NPs). Funds from USAID will be administered by the Michigan State University (MSU).

CDD-Ghana supervises NPs in Cameroon, Cape Verde, Ghana, Liberia, Nigeria, and Sierra Leone; Idasa supervises NPs in Botswana, Lesotho, Malawi, Mauritius, Mozambique, Namibia, South Africa, Swaziland, Zambia, and Zimbabwe; IREEP supervises NPs in Benin, Burkina Faso, Cote d'Ivoire, Guinea, Madagascar, Mali, Niger, Senegal and Togo; and UON-IDS supervises NPs in Burundi, Ethiopia, Kenya, Tanzania and Uganda. In addition, the Arab Reform Initiative, a partner in the Arab Barometer Network, has been sub-contracted to implement surveys in Algeria, Egypt, Morocco, Sudan and Tunisia. The NPs implement the surveys, with Core Partners providing quality assurance through technical support.

The Project Management Unit (PMU) of the Afrobarometer is based at CDD-Ghana. It is made up of the Executive Director, the Deputy Director, Operational Managers, the Project Accountant, and the Monitoring & Evaluation Officer, the Network Data Manager and the Network Sampling Specialist. The unit handles the day-to-day administration of the Afrobarometer and oversees survey, capacity building and communications activities, as well monitoring and reporting.

This report covers activities undertaken as part of AB R5 between January 1 and December 31, 2012.

Planned Round 5 Year 2 Activities

Based on the Workplan submitted to Core Donors in 2012, the activities planned for Year 2 of Rounds 5 and 6 (2012) included the following:

Round 5 Year Two (January – December 2012) Achievements

The following activities and achievements were realized during Year 2 of AB R5 (January 1 to December 31, 2012):

NETWORK MANAGEMENT

Fundraising

During 2012, the AB Network made substantial progress in securing more funding required to implement its plans for Rounds 5 and 6. Achievements included:

1. In the first quarter of the year, the AB Network finalized the contract with DFID for funding of Rounds 5 and 6 for £8M, which is approximately \$12M.
2. To date, the Network has signed contracts with the following Donors support for Rounds 5 and 6:
 - The Mo Ibrahim Foundation (\$2.5m)
 - SIDA (\$2.6M)
 - USAID (3.12M)
 - DFID (12M)
 - The World Bank(\$0.25M) for inclusion of questions on service delivery and cell phone usage
 - AB also signed a contract with the Institute of Development Studies at the University of Sussex in connection with the project "ICTD: Citizen Perceptions of Tax in Africa" (IDS-ICTD) for a R5 contribution of \$0.14M to include their questions on taxation in the AB R5 questionnaire.

If current expected commitments are completed, AB would have raised approximately \$20.6 million. This is against a current total budget goal of approximately \$27M, which had been reduced from the original budget request of \$30.4M for Rounds 5 and 6 by removing the Round 5.5 surveys, delaying hiring in some positions, and some other adjustments.

3. An additional Core Donor commitment is expected to be received in 2013 from the World Bank.
4. In 2012, AB continued to followup with several other prospective donors, including African Capacity Building Foundation (ACBF), the Open Society Institute (OSI) and the United Nations Development Programme (UNDP) in order to secure full funding for Rounds 5/6.

5. The following amounts had been disbursed to the AB Network by December 31, 2012:
- SIDA: \$1.26M
 - Mo Ibrahim Foundation: \$1M
 - USAID: \$1.5M
 - DFID: \$4.43M
 - World Bank: \$0.17M
 - IDS-ICTD: \$0.11M

In 2012, we lost one of our core donors, CIDA. This amounted to a loss of \$3.2M. As a result, the Network has had to put on hold, some activities planned for R5 and 6 and cancel surveys planned for R5.5. This has therefore reduced the fundraising goal from \$30.4M at the beginning of R5 to \$27M, resulting in a total current shortfall of \$6.4M. If we are able to raise more funds, we will be able to undertake some of the activities that have currently been shelved.

Network Staffing

In line with plans to strengthen and restructure the management of the AB Network, the network achieved the following:

- Recruited a Network Communications Manager, who will be joining the team in April, 2013.
- Our recent effort to recruit a Capacity Building Manager to join the team, based at UCT, was unsuccessful (one of the top two candidates took a tenured faculty position, and the other turned down the job for other reasons). We will re-launch the recruitment process in early 2013.
- New Assistant Project Managers were recruited at IDS, IREEP and Idasa and a Communications Coordinator at IREEP.
- Funds were provided for administrative support (part-time) for all Core Partners units.

With the addition of the Communications Manager, the Network will be able to work on the revision of the Communications Strategy and launch some of the planned Communications activities under the new Strategy.

Core Partner and National Partner Contracting

Sub-contracts were signed with all Core Partners and with the UCT Support Unit for Year 2 activities. In addition, National Partner contracts were completed with most National Partners in Year 2; the remaining few will be contracted by the end of March 2013. This is in line with plans to complete all surveys and related activities by June 2013.

Arab Barometer Collaboration

During AB Rounds 5 and 6, one mechanism for meeting the goal of expanding into up to 35 countries on the continent during R5 is collaboration with the Arab Barometer, which has already been conducting barometer-type surveys in North African and the Middle East. A contract was signed in the third quarter of 2012 with the Arab Reform Initiative for collaborative work on five surveys in North African countries (Algeria, Egypt, Morocco, Tunisia and Sudan).

Executive Committee Meetings

ExCom meetings were held by teleconference in April and September, 2013. The primary issues discussed were fundraising and new country assessments. Agendas and minutes are available on request.

Human Resources Development and Institutional Strengthening Plans

Development of Human Resources Development and Institutional Strengthening Plans has been moved out to the second half of 2013 in order for the Network to focus on completing R5 surveys and related activities during 2012. The AB Network plans to engage management consulting support to develop these plans.

Other Network Management Activities

AB Newsletter

Four newsletters, the March, June, October and December editions, were produced in 2012 and distributed to all Partners in the Network.

Monitoring and Evaluation(M&E)

As part of efforts to improve reporting and to build a robust M&E system within the Afrobarometer, M&E capacity building sessions were introduced with Core Partner teams to take them through the AB procedures for tracking deliverables of surveys and related activities, their M&E roles and responsibilities, and how to effectively track AB's efforts in achieving its targets. Three separate training sessions were held in May for IREEP team in Benin, June for CDD-Ghana team, and September for IDASA in South Africa. Generally the CPs found the sessions very useful. This interaction with our partners has significantly improved reporting this year. Core Partners have become more responsive and send information on project activities in a more timely fashion. They are also expected to transfer this knowledge and skills to the National Partners they manage to ensure AB builds a strong M&E system.

In addition, the AB Monitoring and Evaluation Officer, based at CDD-Ghana, tracked all ongoing activities within the Network, and kept records on AB use and policy visibility. AB also tracked media coverage both in Africa (CDD) and globally (MSU), as well as website usage and usage of the Online Data Analysis facility. The various information we track is used to regularly update the "AB CV", the Project's complete record of activities, usage and impact. A list of M&E indicators is included in the AB Indicators Tracker, attached as Appendix 3.

External Audit of AB R5 Year 2 Accounts

An external audit of AB R5 Year 2 (2012) accounts, which started in February 2013, is expected to wrap up before the end in March 2013. The report will be made available as soon as the auditors complete their work.

Surveys and Analysis

New Country Assessments and Partner Recruitments

New country assessment missions took place in 2012 in the following countries: Burundi, Cote d'Ivoire, Cameroon, Guinea, Seychelles and South Sudan. All but South Sudan were confirmed for inclusion in AB R5. Ethiopia was also approved for inclusion in Round 5. In addition, Afrobarometer had hoped to include South Sudan as its 35th country, and recruit a partner there in early 2013 to complete fieldwork by April. However, the high costs of survey work in South Sudan meant that a survey could only be carried out there if additional funding was secured in time. This was not the case, so South Sudan was recently replaced by Swaziland as the 35th country.

Recruitment of new National Partners was undertaken in Burundi, Cameroon, Cote d'Ivoire, Guinea, Lesotho, Niger and Togo. We will be partnering with the following institutions in the following countries:

- Burundi - Groupe de Recherche et d'Appui au Développement des Initiatives démocratiques (GRADIS)
- Lesotho – Advision Lesotho
- Niger – Laboratoire d'Etudes et de Recherches sur les Dynamiques Sociales et le Développement Local (LASDEL)
- Togo - Center for Research and Opinion Polls / Centre de Recherche et de Sondage d'Opinions (CROP)

Lesotho and Zambia have already been part of the AB network, but National Partners in these countries were changed in Round 5.

Final decisions on the partner selection for Cameroon, Cote d'Ivoire and Guinea will be made in early 2013. Partner recruitment in Ethiopia and Swaziland will also be carried out in early 2013.

Surveys

In 2012, fieldwork was completed in 17 additional countries, raising the total number of countries surveyed so far for R5 to 21. Countries surveyed were Botswana, Burkina Faso, Burundi, Ghana, Lesotho, Liberia, Malawi, Mali, Mauritius, Mozambique, Namibia, Nigeria, Sierra Leone, Tanzania, Togo, Uganda, Zimbabwe; in addition to Benin, Cape Verde, Kenya and South Africa surveyed in 2011.

In addition, preparations for surveys were made in Niger, Madagascar, Senegal and Zambia, all of which will undertake surveys early in 2013. Preparations were also underway in the five Arab Barometer countries.

Afrobarometer will provide intensive and expedited Technical Assistance in the five countries (Cameroon, Cote d'Ivoire, Ethiopia, Guinea and Swaziland) for which partners are only being recruited in early 2013 so that surveys will also go to the field in these countries as soon as possible. We are on target to have all remaining countries surveyed by approximately April 2013.

Data Cleaning and Merging

By the end of 2012, data sets had been finalized for 12 countries. Data sets for an additional 9 countries are in the process of being finalized. An initial 12-country Round 5 merged data set has been created and is available for analysis. Additional countries will be added as they become available.

Data Release

According to Afrobarometer's current protocols, data sets should be publicly released one year after the completion of fieldwork. In keeping with this protocol, data sets for Benin, Cape Verde, Kenya and South Africa were publicly released on the Afrobarometer website in late 2012.

Capacity Building

Mentoring Program and Data Management Exchanges

Due to the relatively late start of R5 surveys, the Mentoring Program, designed to provide one-on-one support to NPs needing assistance with analyzing data and preparing materials for release, did not get underway in 2012 as planned. However, one newly appointed AB National Investigator in Benin, Richard Houessou participated in fieldworker training in Nigeria to observe first hand how the training sessions and other fieldwork related activities are undertaken. With most of the new partners releasing results in 2013, they will need mentoring support and the program will be (in fact, in most cases they are likely to be providing this support to other NPs with lower capacity).

Data Management Exchanges will take place only for countries where particular challenges arise in the data management process. The Network Data Manager would provide such special support to NPs as and when the need arises.

Kathy Addy, AB Communications Officer did a lot of mentoring by working with NPs in various AB countries regarding how to constitute stakeholder groups and solicit inputs into country questionnaire development and securing stakeholder buy-in.

Emmanuel Gyimah Boadi, Executive Director of the Afrobarometer did mentoring for CDD-Ghana staff on the development of AB Ghana data briefing papers.

Round 5 New Partner Workshop

A training workshop for new National Partners was held in Kenya in July 2012 hosted by our Kenyan Core Partner, UON-IDS. Representatives from ADVISION - Lesotho, LASDEL - Niger, Centre de Recherche et de Sondages d'Opinions (CROP) - Togo, GRADIS - Burundi and RuralNet Associates Ltd - Zambia participated in the workshop. Also present was a representative of the Arab Barometer team. Areas covered during the workshop include an overview of the AB project, a review of the R5 questionnaire, Sampling, Survey Management, Monitoring and Evaluation, AB Website and Online Data Facility use, Data Analysis and Reporting, Budgeting, Contracting and payments procedure, Network Communication, Dissemination and Communication. Feedback on the workshop was very positive with a majority of participants describing the workshop as very useful. We plan to hold a couple more of these in 2013 to build the capacity of the new partners.

Summer Schools

In order to address the significant differences in format and deliverables between the Anglophone and Francophone Summer Schools highlighted by the R4 Evaluation, the Network managers of both schools will work closely to standardize curriculum, and various other activities undertaken during and after these sessions.

The Anglophone Summer School which is usually held in November or December at the University of Cape Town, was moved to January of 2013 due to a conflict with the UCT calendar in 2012. The 2012 Francophone Summer School was cancelled to focus on the increased number of Francophone countries to be surveyed in Round 5. The next Francophone Summer School will be in 2013.

Second New Partners Planning Workshop

This was cancelled due to time constraints, limited funds and not having all the new partners on board by the fourth quarter. Intensive one-on-one technical assistance was provided by network for the new partners on board in lieu of the planned second workshop.

Communications

Stakeholders Workshops

Implementation of Stakeholders Workshops exceeded expectations. These groups, which are being piloted in selected AB countries during R5, bring together 8-10 influential stakeholders from within the policy community in each country. Participants contribute to the development of Country-Specific Questions, and assist NPs with promoting AB in policy circles within their respective countries. Meetings with stakeholder groups were held in nine countries in 2012: Burkina Faso, Kenya, Malawi, Mozambique, Namibia, Nigeria, Tanzania, Ghana and Zimbabwe. This brings the number of countries where stakeholder workshops were held to 13, exceeding our Round 5 target of piloting the workshops in 10 countries

R5 Results Released and Published

Using the new model of rolling release of results, results for R5 were released in 11 countries in multiple dissemination events. These events happened in Benin, Botswana, Cape Verde, Ghana, Kenya, Malawi, Mauritius, South Africa, Tanzania, Uganda and Zimbabwe.

Benin has so far held 3 major dissemination events for audiences made up of journalists, civil society practitioners, academics, development partners and government officials. They also did 3 separate briefings for councillors of the Prime Minister, Members of Parliament and some local politicians; and another one for development partners. Botswana held 3 briefings for audiences consisting of government officials, politicians, civil society and the media.

The team in Cape Verde held 7 release events. Key among them were briefings for the Prime Minister and his advisors, the President and staff, presentation to the members of National Assembly, ministers and secretaries of state and other parliamentary groups. 3 release events have been held in Ghana so far, consisting of 1 donor briefing and 2 others for civil society practitioners, academics, media, business and donor community members. Kenya has held 3 release events which were attended by civil society practitioners, development partners, academics and representatives of government ministries.

Mauritius held 3 events for journalists, ambassadors and members of the diplomatic corps. South Africa held 4 release events for an audience of academics, civil society practitioners, development partners, government officials and religious leaders. They also held a separate briefing for the staff of their Government Communications and Information Systems (GCIS) Department in Pretoria. Tanzania has held 1 release event while Uganda has held 2 events so far to share the findings of their survey with the Media, Political Leaders, Academia, Civil Society and the Donor Community among others. Zimbabwe had 1 Donor briefing and 4 others for the media, academics, political parties and civic organizations.

While the Afrobarometer protocol requires that each National Partner organises at least 4 release events to share the findings of the survey with stakeholders in-country, only a few countries have released their data fully and we expect to have more release events in 2013. In R5 Uganda was the quickest to release its data, holding its first dissemination event 28 days after field work was completed. It however took Tanzania 144 days from the completion of fieldwork to when it held its first dissemination.

It must be added that though fieldwork in Sierra Leone and Liberia were completed in July 2012 the teams are yet to hold their initial release events. There were initial challenges with their data but this has been resolved and both teams are currently working urgently on preparatory activities for their release events.

This rolling release method has generated a lot more interest and coverage in the countries released.

As part of the new protocol for releasing results, we have revised the model for what documents are released, and are also aiming to post documents to the AB website simultaneously with their in-country release. In the past, we only released Country Bulletins and Summaries of Results (SORs), and only posted published Working Papers and Briefing Papers, along with SORs. The new release protocol calls for the preparation of press releases and powerpoint presentations for the first three events, and these are now posted on the website as "Preliminary Results". We are also including links to media coverage on the results page for each country. We have posted release documents (including Press Releases, Media Briefings (powerpoints), SORs and/or Briefing Papers), along with media coverage for 11 countries, including:

- 18 Press Releases
- 18 Media Briefings (powerpoints)
- 9 Summaries of Results
- 8 Briefing Papers

Note that as in the past, partners produce "Country Bulletins" as their final dissemination product. When these bulletins meet the necessary standards for the quality of the presentation and analysis, they are published as Afrobarometer Briefing Papers. So far 8 bulletins have been published as AB Briefing Papers in Round 5. In addition, the Network published 4 Working Papers which are not linked directly to a country release of results. The Network also produced a Poverty Indicators Bulletin for South Africa which was released in January 2013. More of these indicators bulletins may also be produced as time and human resources allow. All of these publications are available on the Afrobarometer website (www.afrobarometer.org). See Appendix 3 for additional details.

An additional step taken to facilitate both the production and publication of these various products was the development of Dissemination and Release Guidelines and Templates that assist NPs in the production of each type of document. These have greatly improved the quality and consistency of what we produce, and make it easier to produce documents and to move quickly from production and finalization to publication. The templates will be translated into French in early 2013.

AB Website and Online Data Analysis

The AB Website got another major upgrade during 2012 to keep up with new web management software and meet our needs for greater functionality. The Francophone version of the website was completed in 2012. Mean monthly visitors to the Afrobarometer website was 3473 in 2012. The average monthly visits from Africa has also increased by 18%, representing some 730 visits in 2012.

We continue to post data sets also to the Online Data Analysis (ODA) facility (which was also upgraded by the hosting organization during 2012). We also adopted a new policy of passing on final data sets to the web hosts when they are finalized, rather than when they are released one year after fieldwork. This means that they become available via the ODA facility around the same time the first dissemination events are held, or shortly thereafter. This gives users much earlier access to this new data from AB countries.

Visits to the Online Data Analysis facility in 2012 from distinct users were 10,348, or about 862 distinct users per month. This is an increase of 21% from the 2011 figure of 710. South Africa is the 4th highest users of the facility globally (about 4% of all visits). We continue to make presentations about the site, especially to African users, and expect visits from the continent to increase as awareness of the facility spreads, and as connection and access quality improve.

Revise R5/6 Communications Plan

The review/revision of the Communications Plan has been moved to 2013 after the new Communications Manager is on board.

Tracking Media Coverage

Media coverage for AB was tracked in 2012 through the efforts of our national partners, who report mention of AB in their countries to the PMU. This is augmented with the services of a media monitoring company, Meltwater, which helps the Network track media coverage both in Africa and globally. In 2012, AB was cited about 450 times in both electronic and print media.

AB on Social Media

AB has just begun establishing a presence on social media by opening Twitter and Facebook accounts. We now tweet whenever new documents are posted to the website, and are being followed by a number of organizations and journalists. We are expecting the new Communications Manager to help us make full use of these outlets.

Round 5 Year 3 (2013) Workplan

The focus of Year 3 activities will be on completing surveys and dissemination in all Round 5 countries and conducting the Round 5 Global Release, as well as launching more comprehensive communications activities, and engaging in an intensive round of capacity building activities. We were not quite able to meet our goal of completing all Round 5 surveys by December 2012, but we anticipate being able to complete fieldwork by the end of April 2013. We expect to complete data cleaning and merging processes by approximately July 2013, and undertake the Global Release of Afrobarometer Round 5 results from August-September 2013.

During 2011-2012, the focus of the Network has been on successfully expanding our survey coverage from 20 countries in Round 4 to 35 countries in Round 5. We have also revised dissemination activities to into what we call "rolling release of results" to extend public engagement with the data. In 2013, our attention will shift to strengthening and deepening the communications program, which will be aided by the hiring of a senior Communications Manager for the Network, effective in March 2013.

In addition, while some Capacity Building activities have been implemented during 2012-2013, due to both funding constraints and the focus on surveys, they have been at a reduced level. However, during 2013 we will be reinvigorating the Capacity Building program by, re-launching the Summer School and Fellowship programs, and engaging in more in-depth training of our new National Partners. These efforts will be led by a new Capacity Building Manager who will also be taking up his post in early 2013.

Overall, the Afrobarometers full scope of Round 5 and 6 activities is not yet fully funded, but we do have funding commitments at a sufficient level to implement most of our Communications and Capacity Building activities during 2013. Note, however, that our budget shortfall has forced us to cancel plans included in the original proposal to implement Round 5.5 surveys in up to ten countries.

CONCLUSION

In 2012 Afrobarometer focused on the completion of new country assessments and selection of new NPs; getting new partner institutions trained and ready for surveys, and getting as many countries surveyed as possible. This was made possible by an increase in cashflow from our Donors. The Network plans to have surveys for all 35 countries completed by April/May of 2013, and global results released by August/September 2013. Due to the shortfall in raising the full budget, the Round 5.5 surveys and some activities under Capacity Building and Communication planned for R5 and 6 have been shelved. We will continue with our efforts to raise more funds and depending on when the funds come in, we will be able to undertake some of the activities shelved in 2013 and subsequent years for R6.

AB is grateful especially to its Core Donors – which now include Mo Ibrahim Foundation, SIDA, DFID, and USAID – as well as to the the World Bank and the IDS-ICTD for supplemental funding – for the confidence shown in the Network's work, and for their continued support of the Afrobarometer.

NATURE OF BUSINESS

The Afrobarometer is a comparative series of public attitude surveys on democracy, markets and civil society in Africa. It produces scientifically reliable public opinion data, builds research capacity among African institutions, and broadly disseminates practical results.

The project aims to:




